TABLE OF FEES FROM 1ST APRIL 2010

Reduced fees below apply to where the person to be buried or in respect of whom the right of grant is, or immediately before his death was a resident of Thorne-Moorends, or in the case of a still born child, where one of the parents is, or at the time of the interment was, such an inhabitant or parishioner.

WHERE THIS IS NOT THE CASE, FULL FEES WILL APPLY EXCEPT:

- a) For the first interment in a grave pre-purchased by or on behalf of a resident.
- b) Where the interment is for a person who has been permanently resident within the past two years.

i.	Headstone not exceeding 3ft 6" in height or cross not exceeding 4 ft 6" and up to 6" in depth.	137.75
ii.	Kerb Sets not exceeding 7 ft x 3 ft (Posts 8" in height, Kerb 6" in height and 4" in width)	148.50
iii.	Vault or ledger type memorial covering the whole of the grave area not exceeding 7ft x 3ft	292.65
iv.	Additional inscription	33.40
v.	Tablet for cremated remains (base 2'x2') (plaques 18"x18")	54.90

14. Charges for exhumation, burials outside normal working hours etc. will be provided on request.

15. Charges for researching grave numbers will be at the Council's discretion.

16. Graves that were pre-purchased between 1st January 1976 and 31st January 2005 still include the cost of the 1st interment.

17. Any owner of a pre-purchased grave wishing to exchange to another grave is to pay the difference in charges and £20.90 administration fee.

18. Young Person's area. Novelty headstones, for example: children's characters will not be permitted in the main cemetery but will be allowed, subject to approval, in the Young Person's area located at the north-east corner of the cemetery. No painted headstones.

NOTES

The Council must approve details of all headstones, vases, monuments etc. in advance.

Some designs and/or inscriptions may be deemed to be inappropriate and the Council reserves the right to refuse permission under such circumstances.

All inscriptions to be in either: BLACK, GOLD, SILVER or LEAD.
