0003. ELECTION OF CHAIR

0004. ELECTION OF VICE CHAIR

Resolved to appoint Cllr. Ron Powell as vice chair.

0005. DELVES WATER MANAGEMENT

- SD made us aware of an email regarding the Delves from the original White Lane developer. Plans were in place at that time to look after the area. Email to follow after meeting for our information.
- AK asked about the abandoned pond as water was drained of into this pond when the delves ponds were too full. RP commented on acidity so this was not possible. Abandoned pond owned by Network rail.
- Delves are currently in flood zone 3 and since April 2018 have largely appeared flooded – AK mentioned that 12 pegs are currently under water and the area has not seemed low in over a year.
- RP would like us to seriously consider using the drainage water from the railway embankment, MH endorsed this option being explored – would likely come at a very high cost
- MG discussed having a hydrologist give us a presentation on bore holes due to no cllrs having enough knowledge to make a sensible, and sustainable decision
- MG informed members that Swanlands have a bore hole and consulting with them may be helpful.
